# **BUREAU CIRCULAR NO. 732**

# Re: MANUAL REVISIONS - CODE 968, AMUSEMENT - INDOOR BUREAU FILING NO. 0002 EFFECTIVE JUNE 1, 2000

The Bureau has filed and the Insurance Commissioner has approved Manual revisions to Sections 2 and 5 to become effective as of **12:01 a.m., June 1, 2000** with respect to new and renewal business only. These revisions result from a Bureau study of Code 968 which was undertaken in order to review the feasibility of creating an alternate classification assignment for health and exercise clubs. The need arose from ongoing disputes between auditors, who generally assign health club managers and front desk personnel to Code 968, and the insured health club operators, who contend that such employees should be assigned to Code 953, Office. The study recommended that a new, separate class be erected for health and fitness clubs, Code 884, Health and Exercise Clubs, All Employees, Including Office.

The rating values for Codes 884 and 968 are shown in the table below:
