RE: UNIT STATISTICAL DATA REPORTING EDIT MATRIX UNIT STATISTICAL DATA MANAGER TRAINING

The DCRB is committed to assisting our members in improving data quality throughout the entire data reporting life cycle. DCRB subjects all Unit Statistical Report (USR) data submissions to a series of edits to ensure that data submitted is consistent with the DCRB's state specific reporting requirements and quality levels with regard to validity, accuracy, and completeness.

To support our members in understanding this process, the DCRB has published the Unit Statistical Report Edit Matrix. The matrix contains the edit specifications that will be performed upon transactional submission in the Unit Data Manager (UDM) which will go into production at the end of the third quarter.

This matrix details all the unit statistical data edits that will be performed in real-time. The edits include the current edits and also has been expanded to include edits typically performed as part of the annual data summarization process to reduce the number of subsequent inquiries to our members. The matrix contains the edit numbers, edit descriptions, and edit tolerances, stage of editing, and outcomes. Unit data reporters should visit the *Data Reporting* section of the DCRB website at www.dcrb.com to view and download the UDM edit matrix.

Additionally, the DCRB will host two online training sessions on UDM. The training will be offered on October 2, 2018 and October 9, 2018. If you are interested in attending either of these sessions please complete the attached form. Also, the DCRB is available to conduct training sessions on an individual member basis upon request.
