# DCRB CIRCULAR NO. 999

To All Members of the DCRB:

## RE: DCRB NEW EXPERIENCE RATING SYSTEM EFFECTIVE ON JULY 1, 2021

Effective July 1, 2021, the DCRB will be implementing a new and fully integrated experience and merit rating system that streamlines the rating process and enhances distribution. The development of the new system's architecture and technology has taken years of careful planning and execution. The new system allows us to calculate ratings in real-time thus capitalizing on being able to issue ratings daily. The recent Experience Rating Plan changes announced in DCRB Circular No. 998 are restated and included in this release.

In preparation for the release of the new system, please take note of the following important enhancements and/or system changes:

### **Issuance of Contingent Experience Ratings**

As announced in DCRB Circular No. 998, the DCRB has established minimum data requirements that allow Contingent Experience Ratings to be issued. To signify that an experience rating is a Contingent Rating, the WCRATING file will include the Contingent Rating Record Type 07. Additionally, if the minimum data requirements are not met, the experience rating modification will not be calculated.

The chart below provides guidance on various experience rating scenarios and what to expect to be included in the WCRATING file. The chart also identifies whether the rating will be available on Central Data Exchange (CDX) and/or the DCRB's Rating and Underwriting Reference (RUR) application.

#### Issuance of Merit Ratings

Effective July 1, 2021, DCRB Merit Ratings will now be presented on the customary Rating Worksheet, and not on a separate form. This helps simplify the receipt ratings by using a single form for both types of rating. Also note that unlike Experience Ratings, Merit Ratings cannot be issued on a contingent basis.

The chart below provides guidance on various merit rating scenarios and what to expect to be included in the WCRATING file. The chart also identifies whether the rating will be available on Central Data Exchange (CDX) and/or the DCRB's Rating and Underwriting Reference (RUR) application.

### Daily Issuance of Ratings

The DCRB will change to a daily upload of the WCRATING files to the CDX website (<u>www.cdxworkcomp.org</u>). Files will be sent between 3:00 – 4:00 PM EST. This replaces the current process of issuing ratings twice weekly.

### Automatic Distribution of Ratings due to a Change in Carrier

A change in carrier will result in the automatic distribution of a rating to the new carrier via CDX.

### Name and Address Information on the Rating Worksheet

The rating worksheet will display the primary name as well as the mailing and primary operational address(es) as reported by the carrier on the most recent policy. This change allows DCRB to maintain the integrity of the names and address as reported.

#### Unit Statistical Report Corrections Automatically Generate New Rating Worksheets

Corrections to the exposure and/or loss information reported on the USR will result in the automatic generation of a revised rating worksheet. Previously, DCRB did not issue an updated rating if the correction did not change the actual experience modification. This new approach allows carriers and employers to observe any USR data adjustments.
