BUREAU CIRCULAR NO. 731

To All Members of the Bureau:

Re: MANUAL REVISIONS - CODE 975, RESTAURANT BUREAU FILING NO. 0001 EFFECTIVE JUNE 1, 2000

The Bureau has filed and the Insurance Commissioner has approved Manual revisions to Sections 2 and 5 to become effective as of **12:01 a.m., June 1, 2000** with respect to new and renewal business only. These revisions result from a further Bureau study of Code 975, which was originally studied in 1998, resulting in the creation of Code 897, Fast-Food Restaurant. The further study of this classification was undertaken after a study of Pennsylvania Code 975 was conducted and resulted in the recommendation that the original definitions of Codes 897 and 975 were overly broad and three new classifications were proposed for specified segments of the food service industry. The Delaware study recommendations were as the follows:

- Creation of a new code, 896, Club, N.O.C., for all social, business and fraternal organizations.
- Creation of a new code, 898, Caterer, for all catering businesses (e.g., social, industrial concession or mobile).
- Creation of a new code, 899, Bar, Tavern, Cocktail Lounge, Nightclub and Discotheque, for all retail establishments principally engaged in the sale of alcoholic beverages by the drink.
- Revision of Code 897 to remove all catering operations and narrow the scope to include only fast-food restaurant business operators.
- Redefine Code 975 to include traditional style restaurants (wait staff), dinner theaters and other food service operations not previously cited.

969 AMUSEMENT, OUTDOOR: fairs...... employees. Payroll developed in the operation of a restaurant [or the sale of gifts/souvenirs], when conducted in a physically separate department and by a separate crew of employees. shall be [separately rated]<u>assigned</u> to the [appropriate]<u>applicable</u> restaurant classification. [and Code 928 respectively. SECTION 5

Rulings and Interpretations

CLUB, N.O.C. - 896

<u>Clubs are organized civic, social or fraternal associations (e.g., The Elks, VFW posts,</u> <u>fraternities or sororities) who provide special services for members and members' guests only.</u> <u>The services and/or amenities provided by a club may vary depending upon the extent of each</u> <u>club's facilities and membership. The amenities provided may vary considerably from one club</u> <u>to another and may include but are not limited to: dining rooms, bars, lounges, reading/card</u> <u>rooms, bowling lanes or swimming pools. The club's focus and purpose may be based on a</u> <u>charter. Each club is responsible for electing officers to oversee and enforce the club charter.</u> <u>The charter may include but is not limited to rules and regulations for admitting members,</u> <u>maintaining membership and collecting dues. Periodic meetings are held at the club location to</u> <u>discuss upcoming events, fund raisers and/or club business.</u>

FAST-FOOD RESTAURANT - 897

A fast-food restaurant no wait service. [Catering businesses are further contemplated by this classification. There are different types of catering businesses such as industrial (operating in in-house food service/cafeteria for unrelated businesses), concessions at sports stadiums, theaters or transportation terminals or mobile caters (providing food service from vans or trucks at locations such as construction sites, factories or universities with a large commuter student body). Social caters are hired for single social or business events (e.g., weddings, parties or meetings) and use preplanned menus. The services offered by social caterers vary from buffet meals to meals with wait service which may or may not include alcoholic beverages.]

The term "principally..... gross receipts.

CATERER - 898

<u>There are four types of catering businesses that provide food service: social, industrial or institutional, concession or mobile.</u>

Social caterers are hired for a single event such as a wedding, party or business affair. The social caterer provides the client with a menu of food items, types of beverages, colors of linens, other available amenities and, if applicable, a listing of the types of entertainment. The client is then responsible for choosing food, beverages, color schemes and/or entertainment. Once all of the services to be provided have been determined, the social caterer may produce a contract based on the predetermined services. Alcoholic beverages may be provided at the event, but the sale of alcoholic beverages is not the principle source of revenue. This type of catering may be performed either on the caterer's premises or at the customer's premises.

Institutional or industrial caterers operate under contract to provide in-house food service for businesses, hospitals, nursing homes, schools or similar customers. These catering operations generally plan menus and perform the preparation and sale of food in a cafeteriastyle environment.

Concession caterers are usually located at but are not limited to sports stadiums, amusement parks, theaters or museums. The concession caterer operates under contract with the client facility to provide prepared food and beverages to the client's patrons. Occasionally, the concession caterer may also use "walking vendors" throughout the venue.

<u>Mobile caterers provide food and beverages from a truck with cooking equipment, parked</u> on the sidewalk at locations such as a construction site, factory or university with large commuting student body or travel a predetermined daily route.

OPERATIONS ALSO COVERED:

Also included within the scope of this class are caterers providing food service to unrelated airlines or railroads.

<u>"Meals on Wheels" operations (organizations who provide a service to deliver hot meals to</u> those who cannot prepare the food themselves) are further assigned to Code 898.

BAR, TAVERN, COCKTAIL LOUNGE, NIGHTCLUB OR DISCOTHEQUE - 899

<u>A bar, tavern, cocktail lounge, nightclub or discotheque is a retail establishment principally</u> engaged in the sale of alcoholic beverages by the drink that is open to the general public. These establishments may offer some type of entertainment such as a dance floor, disc jockey, live music or one or more televisions showing sporting events. Such businesses may or may not also prepare food an sell the prepared food to customers for immediate consumption. Where food is not prepared, the establishment may sell packaged snacks. In either scenario food preparation and service is not a majority of the employer's operations.

<u>The term "principally engaged" means more than 50 percent of the establishment's gross</u> receipts.

RESTAURANT, N.O.C. - 975

Code 975 contemplates......service provided. [Also includes retail establishments (e.g., bars, taverns or nightclubs) principally engaged in the sale of alcoholic beverages to the public by the drink or for immediate consumption on the establishment's premises. Such business may or may not also prepare food and sell the prepared food to customers for immediate consumption. Where food is not prepared, the establishment may sell packaged snacks.

Civic, social or fraternal organizations (e.g., a VFW post, The Elks) which may have extensive or limited facilities and services (e.g., dining rooms, liquor bars, lounges, reading and/or card rooms, bowling lanes or swimming pools) are further included within the scope of Code 975.]

The term "principally...... gross receipts.
