PENNSYLVANIA TEST AUDIT PROGRAM BULLETIN #77

Classifications Most Often Involved in Test Audit Differences

At the direction of the Audit Committee, the Bureau tabulated test audit differences by classification over a recent one-year period. Listed below are the classifications found in the highest numbers of differences in that review. This information is being provided so that careful consideration can be given in applying these classifications. It is strongly urged that both Section 2 and Section 5 (Underwriting Guide) of the Pennsylvania Manual be consulted when dealing with classification issues and with regard to these classifications in particular. In the classification listing provided below, any existing relevant Rulings & Interpretation entry (Manual Section 5 R&I) is also cited.

With respect to differences attributable to **Risk Misclassification**, the classifications with the most occurrences were:

- □ Code 461, Machine Shop
 - Manual Section 5 R&I Tool Mfg. (Precision Machining).
- Code 601, Road Construction
 - Manual Section 5 R&I Snow Plowing
- □ Code 652, Carpentry Detached Dwellings
- □ Code 811, Trucking
- □ Code 924, Wholesale Store, N.O.C.
 - Manual Section 5 R&I Wholesale/Retail Definitions
- Code 925, Hardware Store Retail
 - Manual Section 5 R&I Hardware Store Retail
- Code 928, Retail Store, N.O.C.
 - Manual Section 5 R&I Wholesale/Retail Definitions
- Code 971, Buildings

In terms of **Employee Misclassification** differences, the standard exception classifications, <u>Code 951</u>, <u>Outside Sales</u>, and <u>Code 953</u>, <u>Office</u>, constituted over 40 percent of the differences. See Manual Section 1 – Rule IV, A., 2. for specific clarification on the parameters of each standard exception classification.
